INDOOR RESIDUAL SPRAY SLAUGHTER HOUSES, DAIRY FACTORIES, POULTRY HOUSES	FLIES	100 ML IN 10 LITRES OF WATER	REMOVE ALL ANIMALS FROM AREAS TO BE TREATED AND DO NOT USE IN AREAS WHERE DAIRY OR MEAT PRODUCTS OR PACKAGING MATERIALS ARE PROCESSED, PACKED OR STORED. APPLY USING A COARSE SPRAY, APPLY TO WET ALL SURFACES. PARTICULAR ATTENTION SHOULD BE PAID TO AREAS WHERE FLIES CONGREGATE. REPEAT MONTHLY OR WHEN FLIES REAPPEAR.
OUTDOOR STOCKYARDS, AROUND ANIMAL HOUSES, BINS AND COMPOST HEAPS	FLIES	500 ML IN 10 LITRES OF WATER PER 100 SQUARE METRES	USE AFTER REMOVING ALL ANIMALS FROM AREAS TO BE TREATED.
OUTDOOR NESTS	WASPS	100 ML IN 10 LITRES OF WATER	THOROUGHLY SPRAY NESTS AND SURROUNDING AREA. TREAT IN THE EVENING OR EARLY MORNING WHEN WASPS ARE NOT ACTIVE. PLUG ENTRANCE AFTER TREATMENT.

- ALL TREATED SURFACES SHOULD BE FREE OF DUST, DIRT OR FOOD RESIDUES
- TYPE OF SURFACES SHOULD BE CONSIDERED AS SHOWN BELOW:
 - ✓ USE 5 LT OF WATER/ 100 SQUARE METER IF YOU SPRAYED NORMAL SURFACES.
 - ✓ POROUS SURFACES SUCH AS BRICKS, CONCRETE AND UNPAINTED WOOD YOU SHOULD USE 15 LT OF WATER/ 100 SQUARE METER
